## Hon. Steven S. Honigman

Mr. Honigman's legal career has included the private practice of law with commercial law firms, corporate directorships and extensive public service. Appointed by President Clinton and confirmed in office by the Senate, he served for five years as General Counsel of the Navy, the third-ranking civilian leadership position in the Navy Secretariat, with four-star equivalent status.

Since completing his service as General Counsel of the Navy in 1998, Mr. Honigman has provided expertise on a wide range of matters including government contracts, claims and investigations; suspension and debarment proceedings; executive and legislative branch strategies and advocacy; federal responsible contractor, CFIUS and national industrial security requirements; foreign military sales and offset programs; nuclear energy facilities; commercial, securities and class action litigation; alternative dispute resolution; and public policy.

Mr. Honigman serves as a member of the Board of Directors of EWA Information and Infrastructure Technologies, Inc. (IIT), a provider of risk management and critical infrastructure, information security and IT supply chain high assurance solutions to federal government and private United States and foreign industry customers. He is counsel to the Advanced Medical Isotope Corporation (AMIC), a producer of medical isotopes for the nuclear medicine market. He has advised the Pew Charitable Trusts with respect to establishing a marine sanctuary in the Indian Ocean, and advises Ocean For Life, a NOAA National Marine Sanctuaries program that provides summer marine biology educational opportunities combining high school students from the Muslim world and the United States.

Mr. Honigman has edited, appeared in and provided legal services for ALL CITY, a film about graffiti writers in New York City. He also serves as a member of the Board of Directors of ALL CITY Foundation, a not-for-profit organization that is designing and implementing an art-based model for delivering community medicine to at-risk urban youth and families.

Mr. Honigman served as a member of the Board of Directors of DRS Technologies, Inc., a multibillion-dollar provider of defense electronic systems and services, until the company's acquisition by Finmeccanica SpA in a \$3 billion transaction. He also served as a director of The Wornick Company, an employee-owned manufacturer of ready to eat military rations.

Prior to his service as General Counsel of the Navy, Mr. Honigman was a partner in a New York City law firm, where he specialized in international and domestic reinsurance and insurance disputes, transactions and insolvencies; land-use, development and exclusionary zoning litigation; commercial and construction litigation; and appeals concerning interests of older Americans. He was appointed by the Secretary of Defense as a public member of the Military Justice Act of 1983 Advisory Commission. He has chaired bar association committees concerned with military law and the rights of service members. He served as law clerk to the Honorable Jacob Mishler, then Chief Judge of the United States District Court for the Eastern District of New York, and on active duty with the Navy Judge Advocate General's Corps, from whom he received the Navy Achievement Medal.
