Thomas F. Brown III, Rear Admiral, USN (Ret), born in Scranton, Pa., graduated from Mt. St. Mary's College, Emmitsburg, MD. in 1954, before entering OCS at Newport, RI Designated a Naval Aviator in July, 1956.

Served in A-4 squadrons VA-153, VA-125 (three tours), VA-164, VA-155 (CAG-15 Ops), and VA-44 before commanding an A-7 squadron, the VA-37 "Bulls", in 1971. After retirement from active duty in 1985, RADM Brown became a Math teacher and administrator at the junior high school level in San Francisco.
